

General Terms & Conditions for Migros GolfCard

1. Membership of Migros GolfCard

Anyone who wishes to become a Migros GolfCard member should fill out the membership form truthfully and in full and send the form to the following address: Migros GolfCard, Neue Riedstrasse 72, 8112 Otelfingen, Switzerland, e-mail: golfcard@gmz.migros.ch. The contractual partner for the Migros GolfCard is the Migros Cooperative Zurich, Pfingstweidstrasse 101, 8005 Zurich.

By signing the membership form or registering using the online registration form, you agree to the applicable Migros GolfCard General Terms & Conditions (GTC).

2. Conditions of Membership

In principle, anyone holding a valid license (in accordance with the requirements of the Swiss Golf Association) or an official handicap is eligible for the Migros GolfCard. Players currently in training to obtain a license may also apply for membership. Play at our facilities is subject to the official conditions of admission to Migros golf courses. 3. Handicap Management

Migros GolfCard handicaps are managed on the basis of the handicap regulations of the WHS (for more information, please go to www.golfparks.ch/de/migros-golfcard/mitgliedschaft/hcp-und-profilverwaltung).

In order to be able to issue your Migros GolfCard, your address is forwarded to Swiss Golf during registration.

4. Rules and Etiquette

Migros GolfCard members must follow the rules and regulations of [R&A Rules Limited](#) as well as those of the individual golf courses and facilities as green-fee players. You can view the regulations and other information at www.golfparks.ch. Copies thereof are also available at the respective golf course if required.

5. Migros GolfCard

Members receive their personal Migros GolfCard approx. end of February after paying their annual membership fee. The card bears the following information: The player's first and surname, ID number, play level (handicap index), PIN and the year of validity.

All members are entitled to consult their current HCP master data at any time at www.swissgolf.ch/en/mywissgolf/.

If you lose your card, a new card can be issued by paying a replacement fee of CHF 30.-.

6. Data Protection

Personal data is processed in accordance with our Privacy Policy, which can be consulted at www.migros.ch/de/datenschutz. By applying for the Migros GolfCard, the member confirms that he/she has read and agrees to the Privacy Policy.

7. Annual Fees

Annual fees always apply per calendar year, irrespective of the date of joining or leaving. No refunds of any kind will be available, not even pro-rated. The current price list can be found at www.migros-golfcard.ch.

8. Termination and Renewal

The Migros GolfCard can be terminated in written by e-mail or post by November 30 of each year, effective at the end of that year. If written notice of termination is not submitted by the aforementioned deadline, membership is automatically extended by one year. The annual membership fee is then due in full.

9. Exclusion / Rejection of Membership

Migros GolfCard reserves the right to revoke or refuse to grant membership. In such cases, no justification shall be required on the part of Migros GolfCard.

10. Amendment

Migros GolfCard members expressly acknowledge that the GTC are subject to change, which is communicated to them in a suitable form. The current GTC can be consulted at www.migros-golfcard.ch.

11. Applicable Law / Jurisdiction

Swiss substantive law shall apply to the exclusion of all others.

The exclusive place of jurisdiction is Otelfingen, Switzerland.
